## 2008 RULES for the 43rd DeLAND OUTDOOR ART FESTIVAL

Saturday, March 29, 2008 – 9 am to 5 pm      Sunday, March 30, 2007– 10 am to 5 pm  
RULES APPLY TO BOTH JUDGED AND NON-JUDGED SECTIONS

Please read carefully and retain for reference.

1. Only artists and craftsmen displaying their own ORIGINAL work may participate. NO SUBSTITUTE EXHIBITORS will be permitted.
2. FEES: JUDGED SECTION - \$135.00    NON-JUDGED SECTION - \$110.00
- \*3. Only one artist will be permitted to exhibit in each space. A two-person team or partnership may qualify as a single exhibitor if this is adequately explained at time of application.
4. Accepted artist must be present and remain at the festival both days to be eligible for show awards.
5. Space size will be 12' w x 12' l. Artists provide their own sturdy display racks or shelves. Be prepared for sun, wind and rain. **No electricity is available.**
6. Deadline for receipt of entries is March 15, 2008 or when filled. **All exhibitors must check in at registration to obtain their booth space before ever setting up their exhibit.**
7. No refunds for cancellations.
8. Artist's name, hometown and space number must be displayed prominently on the card provided by committee.
9. ***INELIGIBLE for JUDGED Section:*** Work from commercial patterns, knitting, crochet, painted stones, ceramics cast from commercial molds, coin or fork/spoon jewelry, art supplies, velvet painting, picture frames, horticulture, scrap craft, kits, bread dough, novelties, decoupage and sunglasses.
10. ***INELIGIBLE for NON-JUDGED Section:*** Jewelry not made by craftsman, art supplies, velvet paintings, commercial picture frames, sunglasses, dealers imports, and purchased items for resale.
11. Previously received awards or ribbons may not be displayed.
12. Artists are responsible for collecting and forwarding 6.5% Florida Sales Tax to the Department of Revenue.
13. Ribbon Awards distributed at 4:00 pm Saturday.  
Cash Awards distributed at 4:00 pm Sunday.
14. Artists and their immediate families are ineligible for SPECTATOR AWARDS.
15. Pets are not allowed in the display area. Does not apply to service animals.
16. When any rules are violated, the Festival committee reserves the right to ask the artist to leave the show, or remove the offending piece of work.
17. Additional information concerning set-up procedures, parking, maps, motels will be sent to accepted artists.
